- Graduate Apprentices: ₹9,000 Per month
- Diploma Apprentices: ₹8,000 Per month

**Eligibility:**

- 1) **For Graduate Apprentice:** Degree in Engineering/Technology/General streams (B.E./B.Tech.)
- 2) **For Technical Apprentice:** Diploma in Engineering/Technology from board of Technical Education of a State.

**Eligibility Conditions:**

- Training will be governed by the Apprentices Act, 1961 (as amended in 1973, 2014, and 2019).
- Candidates pursuing Undergraduate/Postgraduate programs during the 2024-25 sessions are not eligible.
- Candidates below 14 years of age are not eligible.
- Candidates who have completed their apprenticeship training previous year are not eligible.
- Candidates must have passed their qualifying degree/diploma within five years from the date of application.
- Postgraduate degree holders are not eligible.
- Candidates with one year or more of work experience are not eligible.
- Personal canvassing in any form will lead to disqualification.

**Selection Criteria:**

Shortlisted will be based on the merit of the qualifying degree/diploma.

The final selection will be based on:

- Qualifying degree/diploma merit: 80% weightage
- Interview performance: 20% weightage

**Reservation:**

Reservation for SC/ST/OBC (Non-Creamy Layer) and Persons with Disabilities (PWDs) will be as per the provisions of the Apprenticeship Rules, 1992, and subsequent amendments.

**Documents Required:**

The candidates must bring the following original documents along with photocopies at the time of the interview:

- Degree/Diploma mark sheets and certificates.
- Proof of Date of Birth (Matriculation Certificate or equivalent)
- Bank account proof in the applicant's name (cancelled cheque) linked to Aadhaar
- Community Certificate (if applicable)
- The candidates are required to bring the original documents at the time of interview (High School, Higher Secondary, Degree/Diploma Certificate, Aadhar Card, Bank Account details, Photograph and Community Certificate (if applicable).

- No TA, DA, Boarding, and lodging facility will be provided by this institute for interview.

**Termination of Contract:** The Contract of Apprentice Training of Apprentice can be terminated as per the provisions of the Apprentices Act, (Amended in 1973, 2014, & 2019).
