Report of Scrutiny Committee - Cameraman (SC-37)

Category a) **Diploma in cinematography** from any **recognized institute of national repute** with bachelor degree in any discipline along with experience of camera work in minimum **five** broadcasting quality video production in indoor and outdoor camera work in all postures,

or

Category b) **Diploma in videography** from **Government recognized institution** with experience of camera work in minimum **10** broadcasting quality video production in indoor and outdoor camera works.

or

Category c) Masters degree in video production for Govt. recognized institutions and experience of camera work in indoor and outdoor broadcasting-grade quality video productions with minimum 5 broadcasting quality video production in indoor and outdoor camera work in all posters.

Or

Category d) **Diploma in photography** from **government recognized institute** with degree in any field from **government recognized institute** with experience of video camera work for about 20 years in minimum 20 broadcasting quality video productions at indoors and outdoors.
