NITTTR, Bhopal invites application for the post of Technical Resource Person (Role: Software Developer) purely on contract basis for its campus at Shamlu Hills, Bhopal Relevant details are given below:

- a) **No. of post:** 01
- b) **Nature of Appointment:** The appointment is purely on a contractual basis for a specific period for one year, and it does not confer any right to regularization or permanent appointment. The contract can be terminated at any time by either party by giving one month's notice or salary of one month in lieu thereof.
- c) **Tenure:** One Year, extendable up to one year based on the performance and need. The tenure of the contract shall be from the date of joining and shall automatically expire at the end of the contract period unless extended in writing.
- d) **Job Description:** Full Stack Web Development using Java Technologies and MySQL, Development of web dashboard for various categories of users. Writing queries/views etc, Integration/Migration of data using APIs and generation of e-certificates, e-marksheets and data sheet. Liaisoning with third party agencies for data collection, migration and data processing to produce required output.
- e) **Minimum Qualification:** B.E / B.Tech with minimum 55% marks in CSE/IT/EC discipline or MCA/MSc(CS/IT) with 55% marks or equivalent grade in general category or 50% in case of SC/ST/PWD from a recognized University.
- f) **Details of experience:** : Minimum 18 months of work experience in Full Stack Web Development using Java Technologies (JSP/Servlet/Spring Boot/JPA/API Integration etc.) and MySQL Server in live projects in any reputed Institutions/Organizations. Skilled in Data Processing, Report Generation and Exposure in Learning Management System.
- g) **Consolidated Remuneration:** Up to Rs.50,000/- Per Month (Negotiable) as per recommendation of selection committee.

  - Upper age 35 years as on 30/6/2025.

3. All qualifications should be from Indian Universities or Institute's approve / recognized by appropriate statutory /authorities.
