Rationale

The government of India declared the National Education Policy (NEP) 2020. Quality universities and colleges are the vision of the Higher education system. It is stated in the policy that quality higher education must aim to develop good, thoughtful, well-rounded, and creative individuals. Policy provisions for higher and professional education are addressed in part II and part III of the NEP 2020. NEP 2020 Section 9 details the vision of the higher education system. This policy envisions a complete overhaul and re-energising of the higher education system to overcome the challenges and thereby deliver high-quality higher education, with Equity and Inclusion.

NPE 2020 part II details professional education, adult education, lifelong learning, promotion of Indian languages, arts and culture, technology use and integration, online and digital education and creating a dedicated unit for the building of world-class, digital infrastructure, educational digital content and capacity.

The intent and spirit of the policy are communicated to all stakeholders through webinars and awareness programmes. In this context, NITTTR, Bhopal is organizing an orientation programme on the implementation of NEP 2020 for educational leaders and faculty members of higher and technical education.

The orientation programme will provide inputs on themes such as multidisciplinary university, vocationalization of higher education, training and research and technology in higher education. The orientation programme will be addressed by Dr. C. C. Tripathi, Director of NITTTR Bhopal, and senior faculty members of NITTTR, Bhopal.

More about National Education Policy 2020-NEP 2020

NEP 2020 Section 9 details the vision of the higher education system. NEP 2020 section 10 details institutional restructuring and consolidation. It recommends establishing multidisciplinary universities and higher education clusters and autonomous colleges. NEP 2020 section 11 details holistic and multidisciplinary education. NEP 2020 section 12 details the optimal learning environment and support for students. NEP 2020 section 13 details the motivated, energized and capable faculty. This section details the faculty recruitment, training and development and performance assessment. It states the importance of outstanding and enthusiastic leaders. NEP 2020 section 14 details equity and inclusion in higher education. NEP 2020 section 15 details the teacher education imparted in the universities.

NEP 2020 section 16 details reimagining vocational education. NEP 2020 section 17 details quality academic research. NEP 2020 section 18 details transforming the regulatory system of higher education and recommends establishing the Higher Education Commission of India (HECI). It also recommended setting up four independent structures. These are National Higher Education Regulatory Council (NHERC), National Accreditation Council (NAC), Higher Education Grants Council (HEGC), and General Education Council (GEC). NEP 2020 section 19 details the effective governance and leadership for higher education institutions.
